## Attention: VPBANK ANNUAL GENERAL MEETING

Pursuant to the bank's practical necessity to strengthen its Supervisory Board for more effective supervision and control of its activities in line with VPBank's current and future scale as well as headcount, the Board of Directors and Supervisory Board have agreed to add 02 more members to the Supervisory Board, increasing total Supervisory Board members from 3 to 5.
